

## **DICKEY'S BARBECUE RESTAURANTS BEST DAD JOKE CONTEST**

This Agreement is for the purpose of Dickey's Barbecue Restaurants, Inc. ("Dickey's") 12 Days of Christmas in July Contest. Upon the contestant's entry (the "Entry"), this Agreement's terms shall be effectively accepted by the contestant.

**1. Eligibility:** Dickey's sponsorship of the 12 Days of Christmas in July (the "Contest") is only open to legal residents of the United States aged eighteen (18) years or older and is void where prohibited by law. Employees of Dickey's and their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers, their immediate family members, and/or those living in the same household of each are not eligible to participate in the Contest. By entering this Contest, each contestant (hereafter referred to as "You", "Your", "Contestant", or "Participant") agrees to release and hold harmless Dickey's and any Dickey's subsidiary, parent, or affiliate from any injury, loss, damage, death, action, claim, demand or other liability that may occur from entrant's participation in this Contest or from the acceptance, use, or misuse of any prize awarded, or attendance at any event.

**2. Agreement to Rules:** By participating, Contestant agrees to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Dickey's, as final and binding as it relates to the Contest. The Contest is subject to all applicable federal, state, and local laws.

**3. Contest Period:** The Contest Period begins at 10:00 a.m. Central Standard Time ("CST") on July 12, 2021 and ends at 11:59 p.m. CST on July 24, 2021 (the "Contest Period").

**4. Entry is allowed per day during the Contest Period. You may enter up to twelve (12) times during the Contest Period. Unless You are selected a winner during the Contest Period, You will have an amount of entries equal to the number of times you have made an Entry during the contest period (i.e. if You have an Entry for six days but have not been selected a winner, You will have six chances at being randomly selected as a winner for the next prize if the Contest is still in the Contest Period). If you are selected a winner during the Contest Period, Your Entry count for daily prizes will reset to zero and You will need to have another qualified Entry to enter the Contest again to win daily prizes. As for the Grand Prize selection, Your Entry count will not reset even if You have been selected a winner previously.

**5. Prizes:** One (1) winner will be selected at random on any Tuesday-Friday during the Contest Period. Two (2) winners will be selected at random on any Monday during the Contest Period to account for Saturday and Sunday entries. The winner(s) will win the following items: one (1) \$100 Dickey's Gift Card. The winner(s) will be announced by 5 pm CST on Dickey's Facebook Page, and the winner(s) will be contacted through the email their order/mail Entry was associated with. There will also be one (1) Grand Prize Winner. The Grand Prize Winner will be selected at random from every Entry during the Contest Period. The Grand Prize Winner will win the following items: one (1) year of free barbecue from Dickey's, up to a weekly value equivalent to ten dollars (\$10.00) for 52 weeks. The Grand Prize Winner will be announced by 5 pm CST on Dickey's Facebook Page and the Grand Prize Winner will be contacted through the email their order/mail Entry was associated with. Acceptance of any and all prizes constitutes permission for Dickey's to use winners' name, likeness, and Entry for purposes of advertising and trade without further compensation, unless prohibited by law. Dickey's will not be responsible for any loss, liability or damage arising out of any winners' acceptance, use or misuse or failure to use any prize, or element thereof. Returned, undelivered, unclaimed, or unawarded prizes, or any element thereof will not be (re)awarded. Dickey's shall have the right, where necessary, to undertake all action and/or require further information as is reasonable to protect itself, or any of the other promotion partners against fraudulent or

invalid claims, potential public scandal, ridicule, or disrepute in awarding any prize to any winner.

**6. Winner selection and notification:** The entries will be randomized, and a random winner selected.

The Contest winners and Grand Prize Winner will be notified via email and through Dickey's Facebook Page. Dickey's shall have no liability for a winner's failure to receive notices due to winner's spam, junk e-mail, or other security filters and/or settings or for winner's provision of incorrect or otherwise non-functioning contact information. If a selected winner cannot be contacted, is ineligible, fails to claim the prize within fifteen (15) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate winner may be selected.

The receipt by winner of the prize(s) offered in this Contest is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT DICKEY'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

**7. Rights Granted by you:** Upon submitting the Contest Entry, the Contestant warrants and represents to Dickey's that the Contestant has the right to enter into this Agreement and grant the rights granted in it. By entering this Contest, You understand that Dickey's Barbecue Restaurants, Inc., anyone acting on behalf of Dickey's, or its respective licensees, successors, and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, including, without limitation, the winner's name, portrait, picture, voice, likeness, image or statements about the Contest, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without

any further compensation.

**8. Terms:** Dickey's reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Contest should (in Dickey's sole discretion) a virus, bugs, non-authorized human intervention, fraud, or other causes beyond Dickey's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, Dickey's may select the winner(s) and Grand Prize Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Dickey's. Dickey's reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the Entry process or the operation of the Contest or website or violates these Terms & Conditions.

Dickey's has the right, in its sole discretion, to maintain the integrity of the Contest, and to void votes for any reason. Any attempt by an Entrant to deliberately damage any web site or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws and should such an attempt be made, Dickey's reserves the right to seek damages from any such person to the fullest extent permitted by law.

**9. Limitation of Liability:** By entering the Contest, You agree to release and hold harmless Dickey's and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) unauthorized Entry of original artwork not independently owned by you, (ii) such Entrant's participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (iii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware, or software; (iv) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (v) unauthorized human intervention in any part of the Entry process or the promotion; (vi) electronic or human error which may occur in the administration of the promotion or the processing of

**10. Governing Law:** THIS CONTEST IS GOVERNED BY THE LAWS OF TEXAS, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES.

**11. THE PARTIES AGREE TO SHARE EQUALLY IN THE ARBITRATION COSTS INCURRED. TO THE EXTENT PERMITTED BY LAW, THE RIGHTS TO LITIGATE, SEEK INJUNCTIVE RELIEF, OR MAKE ANY OTHER RECOURSE TO JUDICIAL PROCEEDINGS IN CASE OF DISPUTES OR CLAIMS RESULTING FROM OR IN CONNECTION WITH THIS CONTEST ARE HEREBY EXCLUDED, AND ALL PARTICIPANTS EXPRESSLY WAIVE ANY AND ALL SUCH RIGHTS.
